- 14. Mary Bittroff explained the need to update our constitution purposes in order to comply with the Federal Charities Directorate to retain our charitable status that

allows the SSAC to give tax receipts for donations. She also answered questions about the need to have numerous purposes and explained that ALL of our activities had to be serving a charitable purpose in order to maintain our charitable status. By defining specific purposes, it will be easier for the centre to report how each activity serves our membership and it will give those who are involved in planning and creating activities to qualify their services for our members and community. She also emphasized that we do not need to fulfill all of the purposes all of the time such as our meal service that has not been open during the major renovations at present; but, if we did not have such a purpose in our constitution, we would not be able to offer a meal service in the future. Also, if the membership so chose, they could in future make changes by initiating through the board a request to do so at a future AGM or membership meeting and by following the rules set out by the federal Charities directorate. Questions and comments:

- 1. Ron explained cause of renovation delays including the need for additional roof drains, moving of a bearing wall and resulting change in roof trusses resulting in more time lost, contractors having problems with changes in U.S. tariffs and resultant re-order from Canadian sources, inspections supposed to come within 48 hours of requests but came 72 hours later instead, front parking lot proving to be a challenge when a lower level of paving was discovered upon excavation and the new paving needed more preparation work to provide safe grading levels before paving.
- 2. Charlie explained the fixed price contract and how cost changes were calculated due to unknown problems upon commencement of renovations.
- 3. Sylvia explained revenue differences due to renovations and interest charges on Credit Union mortgage draws.
- 4. Emily's chef abilities were appreciated.
- 5. Thanks was expressed to the board and all who worked to keep our centre functioning and to Gillian Smith's work during the renovations. Audience gave a standing ovation!
