President's Message

Thank you to all of you who were so prompt in renewing memberships, and to you hard working reception desk volunteers who processed over 400 applications in January alone! Our membership complement for 2018 is almost 900. Welcome to two new activities. Judi and Bob Wilson are again offering duplicate bridge lessons, and Penny Lightbourne is testing out "Arm Chair" Travel sessions. Volunteer activity chairs are often unsung heroes. and it is important to acknowledge the work they do in preparing, conducting, and completing the paperwork for their activity. As well, they all bring their expertise to that activity, from which all participants benefit. Recently, I heard a heart warming story about one of our activity chairs. Dave Grafton has been leading the Cribbage group on Thursday nights for twenty years, which shows a grand degree of dedication in itself. But, for that all that time, he has also been driving members of that group to and from the sessions!

The Board has postponed the Annual General Meeting, due to the timeline associated with the Expansion project. The new date is Thursday, March 8, 1:30. Please plan to attend, a vote on the project will be presented. The preliminary engineering drawings have been completed, and a construction cost estimate is being prepared. This estimate should be ready by mid-February, which will give the Board time to discuss important parameters, such as financing and closure times, and to determine what decision to recommend to the membership. We will schedule some Information sessions the week before the AGM, to give members more opportunity to discuss the project, and to reach an informed decision. The times for these sessions will be posted in the March Echo, and at the Centre. The decision about proceeding with this project is not just a financial one, although that is important. The disruption in SSAC activities and the effect on members' lives, and how we can mitigate this, is just as important.

Another important topic at the AGM will be the new wording for the SSAC Constitution. A new BC Societies Act came into effect on November 28, 2016. Member societies have until November 28, 2018 to come into compliance with the new Act. There are new regulations about the format and content of the Constitution and By-Laws. The Board will be presenting a new wording for the Constitution, which conforms to the new Act. The wording is contained on page 14 of the Echo, and will be posted at various locations in the Centre. The new format is meant to give flexibility to non-profits. According to the new Act, the Constitution may contain only the Society name, and purpose. Everything else is to be in the By-Laws.

A new Board will be elected at the AGM. I appeal to the huge pool of talent among our members to consider serving on our Board. You will provide a necessary service to your community, but you will also learn and challenge yourself, and you will keep those little grey cells working!



Members, Dave and Christi Blackman, who share in the hobby of keeping marine tropical fish and corals, generously

donated the new pair of Black Onyx Clown-fish (*Amphiprion percula*) to us at the Seniors Activity Centre. These fish are bred in captivity, and the same way dogs can be bred for specific characteristics that make them a Schnauzer or a Great Dane, these fish are thoroughbreds, selected for the genes that give them their striking Onyx colouration. They are a mated pair, so you may observe some very friendly behavior between them. The smaller fish is the male, and the larger fish is the dominant female. Again, we are interested in submissions to name our new fishy friends. And a heartfelt "thank you" to Christi and Dave!



The roles available are for:


- one man, to play 55+. Ability to sound English or Irish an asset

NOTICE: THE ANNUAL GENERAL MEETING WILL BE HELD ON THURS-DAY MARCH 8TH AT 1:30pm IN THE SSAC AUDITORIUM.

In addition to important updates regarding the building improvements and expansion, we will amend our Constitution to bring it in line with current BC Legislation. This does not require a motion, but it is important that the membership know about the changes.

The revised Constitution will read as follows:

SECHELT SENIORS ACTIVITY CENTRE SOCIETY CONSTITUTION

Name

1 The name of the Society is the Sechelt Seniors Activity Centre Society.

Purposes

- 2 The purposes of the Society are:
 - (1) to stimulate the continuing public interest in the welfare of the Society; and
 - (2) to protect the rights and interests of all members.

Rationale: The *BC Societies Act* has been overhauled and Section 10 of that Act now requires that the Constitution be limited to the Name and Purpose of the Society.

We must, therefore remove sections 3, 4 and 5 from our current Constitution.

Our current Constitution reads as follows:

SECHELT SENIORS ACTIVITY CENTRE SOCIETY CONSTITUTION

Name

1 The name of the Society is the Sechelt Seniors Activity Centre Society.

Purposes

- 2 The purposes of the Society are:
 - (1) to stimulate the continuing public interest in the welfare of the Society; and
 - (2) to protect the rights and interests of all members.

Unalterable provisions

- 3 That the Society shall be governed by the principles of democracy and shall be nonpartisan, non-racial and non-denominational.
- 4 In the event of the dissolution of this Society, all the assets of this Society shall be disbursed to registered Seniors Organizations within the District of Sechelt.
- 5 The Society shall insure that its purpose is not for monetary gain of its Members and that any profits or accumulations thereof will be used for promoting its objectives.

In anticipation of the revisions to the *BC Societies Act*, at the SSAC General Meeting on October 15, 2015, the membership approved new By-laws. These new By-laws were designed to contain sections 3, 4 and 5 of the Constitution.

Specifically:

"3 That the Society shall be governed by the principles of democracy and shall be nonpartisan, non-racial and non-denominational" is now reflected in Part 2 of the By-laws –

PURPOSES AND OBJECTIVES

Specifically, By-law 5.2 states:

5(2) To achieve its objectives, the Society will operate in a manner that:

Is democratic; and

(b) recognizes the equality of individuals without regard to race, colour, ancestry, place of origin, political belief, religion, marital status, family status, physical or mental disability, sex, or sexual orientation.

"4 In the event of the dissolution of this Society, all the assets of this Society shall be disbursed to registered Seniors Organizations within the District of Sechelt." is now reflected in Part 10 of the By-Laws—

DISSOLUTION

Specifically, By-law 95 states:

95 In the event of the dissolution of the Society, all the assets of the Society shall be disbursed to one or more seniors organizations within the District of Sechelt that are a registered charity under the Income Tax Act.

"5 The Society shall insure that its purpose is not for monetary gain of its Members and that any profits or accumulations thereof will be used for promoting its objectives." – is now reflected in Part 2 of the By-laws –

PURPOSES AND OBJECTIVES

Specifically By-law 5(1) states

- 5(1) The objectives of the Society are to: ...
- (c) operate without financial gain for its members;
- (d) use any profits or accumulations for promoting the Society's objectives...
