1) Welcome

2) Approval of the Agenda – MOVED/CARRIED by Roy/Fred

4) President's Report - Thanks given to: Val and Tony on work on CRA tax filing; the Property tax exemption is to be done by June. Thank you to Jim for review for the insurance. The Volunteer fair is this weekend: people are needed to sit at the table; Gill to find.

5) Treasurer's Report – March Financials: Alison distributed the comparative Income Statement. Certain negatives numbers reflect from late last year, and January 2022. Kitchen numbers are low; increased costs, plus repairs are an issue, also there are lower numbers for patrons. The Button Program to assist low income diners hopefully will be instituted soon. The Kitchen committee will be asked to address these issues.

Discussion on having sufficient funds to meet the needs of members and the operational costs. MOVED/CARRIED by Alison/Ken to accept the financial report.

6) Maintenance Report – Ken reported the bus will be moving Thursday for new tires and Friday for inspection, then he can get insurance. Suggested we go get \$4-

5,000,000 for liability. Ken will calculate how much each bus trip will cost, which will be re-evaluated after 6 months to see if it is feasible to keep the bus.

Locks are to be inspected, as well as dishwasher valves.

The spring is now on the top portion office door to hold it in place. A deadlock could be changed to the bottom to make it more efficient.

7) Fundraiser Update - 65 tickets have been sold so far for the Ukrainian fundraiser. Donations for the raffle have been coming in.
